About the role

In this role, you will play a key part in maintaining a strong risk culture at Danske Bank, with a focus on standard setting, coordination, follow-up and reporting. The role sits at the more complex end of the Analyst spectrum and requires you to handle cross-functional deliverables, navigate a broad stakeholder landscape, and apply sound judgement in a highly regulated environment.

Your tasks include:

- Drive the development and maintenance of the Group Recovery Plan and support the bank's resolution planning activities
- Provide qualified challenge and guidance on input from other parts of the organisation
- Conduct analytical work on key indicator dashboards and support management reporting and decision-making

- Manage stakeholders across the organisation, including senior governance forums and dialogue with the Danish Financial Supervisory Authority

- Proficiency in a Scandinavian language is beneficial but not required
